

The company follows general manufacturing practices. For each production line there are schedules of cleaning specifically designated for relevant features of our raw materials. The standard part of production process is thorough cleaning of all production lines between different product batches to avoid cross-contamination. The staff involved in logistic chain is educated in proper handling allergen materials if any. No fumigation is used in the company.

Packaging materials conform to the requirements of Directive EC 1935/2004 and 2002/72. Taking into consideration the current requirements of the Regulation 1935/2004 we have implemented system and operational procedures aimed at ensuring the tracking of packaging materials being in direct contact with food products. The purpose of the mentioned measures is increasing of food safety and ensuring the recall of defected products.
